CRC is acting as the fiduciary sponsor for The Play Posse, a nonprofit organization. CRC holds cash The Play Posse has received in grants and pays out funds at the direction of the management of The Play Posse.

Part V, line 4:

Management has considered the following factors in making a determination to appropriate or accumulate endowment funds: the purpose, duration, and preservation of the endowment; expected total return of investments; general economic conditions; and other resources available to CRC. Accordingly, CRC has placed its endowment with the Community Foundation of Snohomish County (CFSC) for administration in accordance with CFSC's policies for the agency funds CFSC holds. This allows CRC to enjoy the advantage of being invested in a larger pool of assets, which can lead to greater growth, income, and lower investment fees.

The primary investment objective of CSFC is to preserve the real value (inflation adjusted) of current assets and future gifts. CFSC manages its endowed and operational assets according to guidelines established by the Board of Directors and Finance Committee. The allocation policy is designed to provide an optimal asset mix for the portfolio, emphasizing diversification in order to lower risk and maximize total return. CFSC's investment goal is to earn, through a combination of appreciation and income, an annual return net of fees of at least 6-8%.
